Exhibitor agrees that upon acceptance into the Art Miami Fair they will not participate in any other shows or fairs in South Florida during the Art Miami show dates.

# **STAND REQUEST:**

Included in the stand cost: 12' (3.65 m.) high perimeter hard walls, one standard table with two chairs, booth signage, drayage, lighting as described below, and listing in online catalog. There are mandatory additional fees for additional stand lighting, additional walls, additional signage, special construction, rigging, miscellaneous electrical services, shelving, sculpture pedestals, sculpture drayage and labor furnished for exhibitor supplied materials. Labor can be provided at an additional charge. Minimum stand size is 300 square feet (27.9 square meters). In addition to the booth fees, there is a mandatory cooperative advertising fee of \$1,800 for stand sizes less than 501 sq. ft. and \$2,400 for stand sizes greater than 501 sq. ft. A wireless internet fee of \$125 is mandatory for all exhibitors and will allow for the connection of up to three devices for the duration of the fair. Corner stands will have a surcharge of \$515.

3. All exhibitors agree to be bound unconditionally by the Informa Markets Art, LLC Terms and Conditions, **available via this link.**

If accepted, the balance of the booth cost shall be paid by Exhibitor in accordance with the assigned payment schedule and no later than 50% by August 1, 2021 and the remaining balance by October 1, 2021. In the event Exhibitor fails to make such payments on schedule, Informa Markets Art, LLC reserves the right to reassign Exhibitor's booth location and/or offer said booth location to other Exhibitors. Exhibitor shall remain fully responsible and liable for any and all obligations as set forth in this Agreement.
